

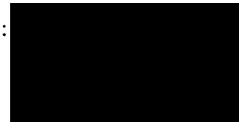

The Petitioner, **MICHAEL J. ROTONDO**, having filed a petition for a violation on February 14, 2017, and a petition for modification for an Order of Visitation (dated October 24, 2011) on April 20, 2017, and the Respondent, **ANGELA C. GASPARINI**, having filed a petition for a modification of the custody and visitation Order (dated October 24, 2011) on February 22, 2017;

And a hearing having been held before this court on September 28, 2017, and the following having appeared, **MICHAEL J. ROTONDO**, with **HEATHER VINCENT, ESQ.**, as his stand by counsel, **ANGELA C. GASPARINI**, with her attorney **DANA F. GRILLO, ESQ.**, and **DARLENE O'KANE, ESQ.**, as attorney for the child;

NOW, after examination and inquiry into the facts and circumstances of the case and after due deliberation; it is hereby

ADJUDGED, that there has been no finding of a violation of the court order by **ANGELA C. GASPARINI**, and the petitions filed by **MICHAEL J. ROTONDO** are hereby dismissed; and it is further

ADJUDGED, that there has been a change of circumstances warranting a modification of the previous Order dated October 24, 2011; it is therefore

ORDERED, that **ANGELA C. GASPARINI**, shall have sole legal and physical custody of [REDACTED], date of birth [REDACTED]; and it is further

ORDERED, that **MICHAEL J. ROTONDO** shall have supervised visitation in a therapeutic setting only; and it is further

ORDERED, that **MICHAEL J. ROTONDO** is precluded from filing any further motions or petitions regarding [REDACTED] or **ANGELA C. GASPARINI** without express advance permission of the Court, to be requested by written application to the Court on notice to all counsel; and it is further

ORDERED, that the Petitioner and Respondent keep each other advised of any changes in address or phone numbers and all communications by Petitioner to Respondent shall be by text messaging only.

PURSUANT TO SECTION 1113 OF THE FAMILY COURT ACT, AN APPEAL FROM THIS ORDER MUST BE TAKEN WITHIN 30 DAYS OF RECEIPT OF THE ORDER BY APPELLANT IN COURT, 35 DAYS FROM THE DATE OF MAILING OF THE ORDER TO APPELLANT BY THE CLERK OF COURT, OR 30 DAYS AFTER SERVICE BY A PARTY OR THE ATTORNEY FOR THE CHILD UPON THE APPELLANT, WHICHEVER IS EARLIEST.
